Regular Monthly Meeting
February 19th, 2024

Sigel Township Hall, 5784 Sand Beach Rd, Harbor Beach, MI 48441

Meeting called to order by Supervisor Maurer at 5:00 pm. Board members present: Maurer, Bischer, Essenmacher, Sweeney and Grekowicz. Also in attendance were Fire Fighters Joel Kiehl, Rusty Lemanski, and Jason Lermont.

Minutes were approved from the January 15th, 2024 Meeting. Motion Essenmacher, second Grekowicz to approve minutes. Motion Carried 5-0.

Treasurer Report: General Fund starting balance \$718,200.56. Income of \$91,268.16 and Expenses of \$15,424.04 for an ending balance of \$794,972.12. Fire Fund starting balance \$358,372.53. Income of \$99,801.65 and Expenses of \$1,322.49 for an ending balance of \$456,851.69. Road Fund starting balance \$172,168.63. Income of \$199,693.55 and Expenses of \$0 for an ending balance of \$371,862.18. Total of all three ending balances of \$1,623,685.99. Motion Sweeney, second Essenmacher to approve all 3 treasurer reports. Motion Carried 5-0.

Motion Bischer, second Grekowicz to pay months bills in the following amounts. General Fund \$15,424.04 checks 1136-1146. Fire Fund \$1,322.49 checks 1860-1865. Road Fund \$0. Motion Carried 5-0.

Supervisor Maurer reported the bid for asphalt on Minden Rd has not been returned.

Motion Grekowicz, second Essenmacher to request the Huron County Road Commission return to individual Township meetings. Motion Carried 5-0.

Clerk Bischer reported the Law Office of Ferris, Schwedler & O'Mara will finish the Road Millage language after the Board of Review Meeting.

Central Huron Ambulance is requesting \$10/resident for coverage of the west half of the Township. No action was taken.

Clerk Bischer reported on early voting for the February election and that turnout for the first three days of early voting has been low with a total of 22 votes cast. Sigel Township Election Inspectors are working in Harbor Beach on February 19th and February 20th, 2024.

The Settlement Day will be held on Monday, March 18th, 2024 at 5:00pm. At its conclusion a Public Hearing on the proposed budget for the 2024/2025 will be held. The Annual Meeting will be held on Saturday, March 30th, 2024 at 1:00pm. Clerk Bischer will publish meeting notices in the Minden City Herald.

Firefighters reported on activities in the township. There were no calls since the last meeting.

Motion Bischer, second Grekowicz to adjourn meeting. Motion Carried 5-0. Meeting Adjourned at 5:45pm.
