## Sigel Township Regular Monthly Meeting July 15<sup>th</sup>, 2024 Sigel Township Hall, 5784 Sand Beach Rd, Harbor Beach, MI 48441

Meeting called to order by Supervisor Maurer at 8:01 pm. Board members present: Maurer, Bischer, Essenmacher, Sweeney and Grekowicz. Also in attendance were Fire Fighters Joel Kiehl and Jason Lermont, resident Andy Kirsch and Road Commissioner John Hunt.

Minutes were approved from the June 17<sup>th</sup>, 2024, Meeting. Motion Essenmacher, second Grekowicz to approve minutes. Motion Carried 5-0.

Treasurer Report: General Fund starting balance \$931,974.64. Income of \$10,655.80 and Expenses of \$16,776.06 for an ending balance of \$926,811.05. Fire Fund starting balance \$428,045.66. Income of \$4,163.77 and Expenses of \$2,520.21 for an ending balance of \$429,689.22. Road Fund starting balance \$53,210.80. Income of \$4,51.48 and Expenses of \$0 for an ending balance of \$57,762.63. Total of all three ending balances of \$1,414,262.90. Motion Sweeney, second Essenmacher to approve all 3 treasurer reports. Motion Carried 5-0.

Motion Bischer, second Essenmacher to pay months bills in the following amounts. General Fund \$16,776.06 checks 1223-1236. Fire Fund \$2,520.21 checks 1896-1898. Road Fund \$0.00. Motion Carried 5-0.

Supervisor Maurer reported that the application of road brine is complete and the Minden Rd paving project is complete.

Motion Grekowicz, seconded by Sweeney to replace a culvert on Cook Rd <sup>3</sup>/<sub>4</sub> mile west of Parisville Rd and at an estimated cost of \$5,500. Motion carried 5-0.

Clerk Bischer reported that the Township website Domain name was approved as sigeltownshipmi.gov. This will allow the next steps in the creation of the website to be completed and the website will be launched soon.

The L-4029 was tabled until the next meeting since the Township Road Millage will be on the August ballot.

During the Ambulance report Joel Kiehl reported that Central Huron Ambulance will be replacing equipment on a 10-year payment plan.

Firefighters reported that the sweatshirts have arrived and will be distributed. All of the fire trucks will be receiving their annual inspection shortly.

During Public Comment, John Hunt spoke about his candidacy for District 5 County Commissioner and his past board experience on the Huron County Road Commission. Andy Kirsch inquired why he pays Huron County taxes for Sanilac County roads. He is unhappy with the condition of Kipper Rd from Parisville Rd to Johnston Rd. After a rain event, water lays on the shoulder of the road. Supervisor Maurer will be in contact with the Road Commission to address the issue.

Motion Bischer, second Essenmacher to adjourn meeting. Motion Carried 5-0. Meeting Adjourned at 8:46pm.
